

Judicial Funding Update

While the Judiciary continues to deal with a budget shortfall, an often overlooked aspect of court funding is the continuation of Act 49 of 2009 by Act 30 of 2011. These acts generate approximately \$26.1 million each year for the Unified Judicial System (UJS) and approximately \$2.5 million for the Access to Justice (ATJ) account.

Both acts required the courts to collect an \$11.25 surcharge on certain court filing fees, excluding vehicle violations. Of the \$11.25 fee:

• \$10.25 is deposited into a separate reserve account within the Judicial Computer System Augmentation Account for the operation of the Judicial Department and

• \$1 is deposited into the ATJ account.

Act 49 will generate the following revenue for the Judiciary between Dec. 8, 2009 and Jan. 7, 2012:

- \$55.8 million for UJS and
- \$5.4 million for ATJ.

Act 30, signed by the governor on July 7, 2011, extends the \$11.25 fee through Dec. 31, 2014.

According to the Administrative Office of Pennsylvania Courts, revenue estimates for the Judiciary during the 36-month period beginning Jan. 8, 2012 through Dec. 31, 2014:

- \$78.2 million for UJS and
- \$7.6 million for the Access to Justice account.

According to the courts, state funds have fallen short of Judiciary needs for several years:

- \$27.5 million in 2009/10;
- \$12 million in 2010/11 and
- \$23 million in 2011/12.

The chart below shows state Judiciary funding decreasing from \$359 million in 2007/08 to \$357 million in 2011/12. These deficits have, in part, been funded by Act 49 revenues and by a cumu-

lative total of \$30 million in unreimbursed loans from the Judicial Computer System as far back as fiscal year 2005/06.

Access to Justice, enacted in July 2002 to provide civil legal assistance to lowincome residents without charge, is also funded by a \$2 surcharge on filings in state courts.
