

# 2014/15 Budget Printout Notes

## About the Printout

The **printout** is a spreadsheet that contains a list of all appropriations authorized and/or proposed to be authorized under the General Appropriation Act(s) (GAA), and non-preferred appropriation acts. Also included are certain executive authorizations, which are approvals by the governor to spend money, based on a previous blanket statutory action of the General Assembly.

The printout is organized according to the structure of the GAA, first by fund and then by department. The General Fund is the largest fund and appears first, followed by smaller funds as shown below:

The printout contains columns showing actual, estimated or proposed appropriations by fiscal year. Often, three fiscal years are shown and are referred to as the actual year, the available year, and the budget year.

Actual Year	The fiscal year most recently ended (2012/13). Actual data reflects supplemental appropriations and other adjustments like lapses.
Available Year	The fiscal year within which the commonwealth currently is operating (2013/14). Available data reflects the most recently enacted appropriations and does not reflect <u>proposed</u> supplemental appropriations or budgetary freezes. Proposed supplemental appropriations are summarized separately.
Budget Year	The upcoming fiscal year for which the General Assembly has not yet enacted legislation (2014/15). Budget year data is based on a proposal, like the governor's executive budget or a budget bill under consideration in the General Assembly.

Although they are not included in the GAA, non-preferred appropriations are listed with the relevant department. The section for the Department of Agriculture includes non-preferred appropriations for agriculture and veterinarian activities (Penn State University and University of Pennsylvania). Also, the Department of Education shows the non-preferred appropriations to the state related universities (Penn State University, University of Pittsburgh, Temple University, and Lincoln University).

## Terms and Definitions

Some terms and definitions are helpful to understand the types of appropriations that are included within the printout, especially the General Fund.

There are two types of appropriations, preferred appropriations and non-preferred appropriations.

- **Preferred Appropriations** reflect most appropriations and are expenditure amounts that require only a majority vote of those elected to the General Assembly. Most often, they are contained within the GAA. Unless otherwise noted in the printout, the appropriation listed is a preferred appropriation.

- **Non-Preferred Appropriations** are appropriations to charitable or educational institutions not under the absolute control of the commonwealth. They require an affirmative vote of two-thirds of the General Assembly and are noted with an “N” on the printout in the column immediately to the right of the name of the appropriation.

**Executive authorizations** are authorizations approved by the governor to spend money based on a previous blanket statutory action of the General Assembly. Examples include tax note expenses and interest on tax note expenses. These authorizations are noted with an “EA” on the printout in the column immediately to the right of the name of the appropriation.

**Supplemental Appropriations** are additional appropriations or adjustments passed after the first enactment of a GAA. They are noted with “Sup” on the printout in an additional column to the right of the name of the appropriation. Supplemental appropriations usually are accounted for in the available year (customarily the fiscal year in which a fund is currently operating).

**Federal Funds** are appropriated as part of the GAA. These appropriations are noted with an “F” in a column to the right of the name of the appropriation on the printout. Some federal funds were made available under the American Recovery and Reinvestment Act (ARRA) and have an AR note as well. The bulk of federal ARRA appropriations were made between 2009/10 and 2010/11.
